

Dear Parent/Carer

#### We are delighted you have applied for a place in our Nursery for September 2022.

At West Hampstead Primary we firmly believe that nursery provides the best start to education and supports all the children (and parents!) to become involved in our community school, to build relationships and to become immersed in the learning journey. I am very pleased to let you know that the West Hampstead governors have agreed to maintain our full time nursery provision for the 2022 - 2023 academic year.

It would really help us if you could complete the attached forms and return them to us as soon as possible. We need some personal information about you and your child and to be able to determine how you will fund your Nursery place at West Hampstead, whether this is through eligibility for either the Government extended offer for the children of working parents or the Camden Enhanced Offer. An outline of all eligibility criteria is detailed below.

Information provided will be treated as confidential and individual details will not be shared.

Please complete the Nursery Application Form and Parent Declaration form which are available on our website or from the school office.

#### Please complete and return all forms to the school office.

All three and four year olds will remain entitled to 15 hours of free early education (15 hours a week for 38 weeks, up to the total of 570 hours). However there is a national offer of 30 hours' free early education - an additional free 15 hours - **but only for working parents who meet** certain criteria. (see Nursery Appendix A)

We require all parents who qualify for the additional 15 hours free funding to apply to the HMRC using the online portal which can be accessed through Childcare Choices at (see Nursery Appendix A):

The Childcare Choices portal will take you through the application process. If you encounter any problems with the application process please direct your queries to the Childcare Service Customer centre on 0300 123 4097.

On completion of the application you will have a childcare service account. If you are eligible for 30 hours free funding you will be given an 11 digit 'eligibility code'. You will need to provide us

with the code and your national insurance number to allow us to claim the funding for your child. You must pass this information onto us by 8<sup>th</sup> **July 2022** so that we are able to ensure that we receive the funding in time for your child's start date in September 22.

If you think you do not meet the eligibility criteria as stated above for the 30 hours free government funding then **please also complete the 'Camden Enhanced Offer' form online at** <u>www.camden.gov.uk/childcare</u>.

This scheme is for Camden residents <u>only</u> and may provide additional funding for any child who does not receive the government offer (see Nursery Appendix). If you are eligible for this funding you will receive a confirmation letter from Camden. Again, we request that you pass this information onto us by 8<sup>th</sup> **July 2022** so that we are able to ensure that we receive the funding in time for your child's start date in September 22.

# **Parent Declaration Form**

All parents accessing a funded nursery place must complete this form with their nursery providers.

All 3 and 4 year olds are eligible for a free early education place of 15 hours a week for 38 weeks per year (term time only) or the equivalent of 570 hours stretched over the whole year.

3 and 4 year olds with working parents may be eligible for an additional 15 hours per week (30 hours in total) term time or the equivalent of 1140 hours stretched over the year.

3 and 4 year olds not eligible for the additional 15 hours for working parents may be entitled to Camden's Enhanced Offer of an additional 15 hours per week term time or stretched over the year. Universal hours must be taken in Camden to receive this enhanced offer.

2 year olds may be eligible for a funded place if the parents are disadvantaged by a low income.

Some 2 year olds are eligible to 570 free hours a year. All 3 and 4 year olds are entitled to 570 hours a year (universal entitlement) and some 3 and 4 year olds from working families may be entitled to an additional 570 hours (extended or 30 hours entitlement) a year. Some 3 and 4 year olds of low income families may also be entitled to extended 30 hours under the Camden Enhanced Offer scheme.

(families on Camden Enhanced Offer must be using their universal entitlement in Camden to be eligible for the enhancement).

### **Disability Access Fund**

If your child is 3 or 4, is receiving child Disability Living Allowance and is receiving the free entitlement, he or she is eligible for the Disability Access Fund (DAF). DAF is paid to your child's early years provider. The purpose of DAF is to support

providers to make reasonable adjustments and build the capacity of their setting to support children with disabilities.

#### **Data Privacy**

The Data protection Act 2018 (the Act) puts in place certain safeguards regarding the use of personal data by organisations, including the Department for Education, local authorities, schools and other early education providers. The Act gives rights to those about whom data is held (known as data subjects), such as pupils, their parents and teachers. This includes:

- The right to know the types of data being held
